



## Conferring Rights to the Health Services Advisory Group (HSAG) Nursing Home Group in the National Healthcare Safety Network (NHSN)

## To Confer Rights and Join the HSAG Nursing Home Group

- 1. Log in to the Centers for Disease Control and Prevention's (CDC's) Secure Access Management Services (SAMS) webpage: <u>https://sams.cdc.gov/</u> and access the NHSN application.
- 2. Under My Applications, click on NHSN Reporting.
- 3. The next page should be the NHSN Landing Page. Ensure your facility is selected and click on submit.
- 4. On the navigation bar on the left side of the webpage, select *Group*, then click *Join*.

- a. Followed by the Group Joining Password (case sensitive): ca40hai
- 6. Select *Join Group* to join the HSAG Nursing Home Group.

Once you have reviewed the template, navigate to the bottom of the page and click the *Accept* button. This will enable HSAG to view your data for quality improvement purposes, but does not allow HSAG to upload or edit your data.
