### CMS F945: Infection Control Training

- Effective October 2022.
- Requires nursing homes to develop, implement, and permanently maintain an effective training program for all staff.
- Includes all facility staff (direct and indirect care functions), contracted staff, and volunteers.
- Facilities must have a process in place to track staff participation in and understanding of the required training.

#### California Skilled Nursing Facility (SNF) Infection Prevention and Control (IPC) Training Resources

#### California Infection Preventionist (IP) Requirements

- California SNFs are required to have a full-time, dedicated IP 40 hours/week.
  - California Department of Public Health (CDPH) All-Facilities Letter (AFL) 20-
- CDPH AFL 21-51.
- Role may be filled by either 1 full-time staff member or 2 staff members sharing IP respor
- Total time dedicated to the role is ≥ 1 full-time staff member.
- IP must be qualified by education, training, clinical or healthcare experience, or certification
- IP must have completed specialized training in IPC.
  - Initial Training—minimum 14-hour program per AFL 20–84
  - Annual Training-at least 10 hours of continuing education in the field of IPC
- Primary professional training:
  - Licensed nurse
  - Medical technologist
  - Microbiologist
  - Epidemiologist
  - Public health professional
  - Other healthcare-related professional

#### **Initial 14-Hour IP Training Options**

The initial 14-hour IPC fundamentals training program should be completed by each new IP with days of hire. This training must be completed by each new IP if a SNF has more than one IP shar existing SNF employee is designated as the IP, that person should complete the initial IP training calendar days of his or her IP role designation. To fulfill the initial 14-hour training requirement, IP access training sources through a nationally recognized IPC association. Ensure IPs receive a certificattendance or documentation of the learning objectives for their initial training to prove attendance completion.



# Vaccine Ambassador Program: On-site Clinic and Education Support



### **No-Cost Vaccination Clinics**

- HSAG is coordinating no-cost vaccination clinics for all staff members and residents, regardless of insurance coverage.
- Minimum requirement is 20 vaccinations of any combination of COVID-19/pneumonia.
  - Can include any combination of staff members and resident vaccinations.





### **HSAG Vaccine Ambassador Support**



An assigned vaccine ambassador will reach out to provide customized technical assistance, including:

- Reviewing current vaccination rates.
- Determining challenges/barriers to increased uptake.
- Scheduling on-site or virtual education support based on facilities' needs/requests.
- Coordinating with the vaccination clinic scheduling team to provide on-site vaccination assistance for staff members and residents.



To date, HSAG's Vaccine
 Ambassador Program has
 assisted 41% of California
 SNFs for vaccine education
 and/or clinics.





# Vaccination Rate Improvement Is Possible!

In California, nursing home support through the HSAG Vaccine Ambassador Program has achieved over:

- 190 education sessions completed.
- 700 vaccination clinics scheduled and completed.
- 13,500 total COVID-19 vaccinations for residents and staff members.
