

## **Medicare Coverage for Vaccinations**

Vaccines help protect people from serious illness and are an important part of healthcare for people on dialysis. Dialysis facilities play a important role in providing vaccines and are required to maintain a vaccination program per federal regulations. The information in this resource can help dialysis facilities better understand how Medicare pays for vaccines. Medicare Part B pays for the following vaccines and their administration as part of its Preventive Services coverage when provided by a dialysis facility:



## To ensure dialysis patients receive the necessary vaccinations, follow these steps:

- Review the Facility Pneumococcal Pneumonia and Influenza Vaccination Dashboards in the End Stage Renal Disease (ESRD) Quality Reporting System (EQRS) to determine which patients need vaccines. - 2. Discuss each vaccine with patients, provide education about their benefits, and obtain information about previous vaccinations received.

- 4. Access state immunization information systems to see if vaccinations have been recorded for the patients. Vaccine	Dosing Frequency	Payment Methodology
Influenza	Once per flu season.     The annual influenza vaccine season runs from August 1 through July 31 of the following year.	<ul> <li>95% of the Average Wholesale Price (AWP).</li> <li>Vaccine and administration are covered.</li> <li>Part B deductibles and coinsurance do not apply for influenza vaccine products or their administration.</li> <li>With respect to vaccine products, all providers and suppliers must accept assignment on the claim.</li> <li>Find more information at: <a href="https://www.cms.gov/flu-provider">https://www.cms.gov/flu-provider</a>.</li> </ul>
